This agreement made and entered into this \_\_\_\_ day of \_\_\_\_\_, (forwarded date) by and between \_\_\_\_\_ hereinafter referred to as “**Bondsman/Client**”, and \_\_\_\_\_ hereinafter referred to as “**Bail Fugitive Recovery Agency/Investigators**”. Whereas **Bondsman/Client** seeks the professional services of **Bail Fugitive Recovery Agency/Investigator**, now therefore, **Bondsman/Client** agrees to pay **Bail Fugitive Recovery Agency/Investigators** at the rate:

1. Any bail surrender and/or forfeited bail bonds forwarded to **Bail Fugitive Recovery Agency/Investigators** within 45 days of forfeiture shall be paid at the rate of 7% or \$500.00 (whichever is higher) of the total of bond(s), for services in effectuating exoneration.
2. Any forfeited bail bonds forwarded to **Bail Fugitive Recovery Agency/Investigators** after 45 days of forfeiture shall be paid at the rate of 10% or \$750.00 (whichever is higher) of the total of bond(s), for services in effectuating exoneration.
3. Any forfeited bail bonds forwarded to **Bail Fugitive Recovery Agency/Investigator** after 180 days of forfeiture shall be paid at the rate of 14% or \$1000.00 (whichever is higher) of the total of bond(s), for services in effectuating exoneration.
4. Any forfeited bail bonds forwarded to **Bail Fugitive Recovery Agency/Investigator** after 270 days of forfeiture shall be paid at the rate of 20% or \$5000.00 (whichever is higher) of the total of bond(s), for services in effectuating exoneration.
5. Any forfeited bail bonds forwarded to **Bail Fugitive Recovery Agency/Investigator** where the defendant/fugitive is located outside the State of Ohio & MI shall be paid at the rate of 20% or \$5000.00 (whichever is higher) of the total of bond(s), for services in effectuating exoneration.
6. Any declarations/reports to be submitted as an exhibit or proof of investigations to the courts shall be paid at the flat rate of \$200.00. *Fee to be paid before declarations/reports submitted.*

**Methods of Exoneration** include but are not limited to: a) Locating, arresting, and transporting the bail fugitive to the appropriate facility; b) Discovering that the bail fugitive is dead and the production of evidence to support that; c) The arrest of the bail fugitive by a law enforcement agency; d) Surrender by **Bail Fugitive Recovery Agency/Investigators**, or by **Bondsman/Client**, of the bail fugitive to a law enforcement agency; e) The bail fugitive is located in custody; or, f) Any other method, including legal maneuvers to be done by **Bondsman's/Client's** attorney, which **Bail Fugitive Recovery Agency/Investigators** may devise or discover whereby **Bondsman/Client** may be exonerated.

**Bondsman/Client** shall forthwith supply **Bail Fugitive Recovery Agency/Investigators** with; 1) A Certified Copy of the Bail Bond(s); 2) A proper Arrest Authorization; 3) A clear photograph of the bail fugitive; 4) A copy of the original bail bond(s) application(s), indemnitor application(s) and agreement(s), and any other available information on the bail fugitive; 5) Detailed skip trace report that is less than 15 days old. **Bondsman/Client** agrees to reimburse **Bail Fugitive Recovery Agency/Investigators** the actual cost of obtaining the above mentioned documents if the **Bondsman/Client** does not provide it.

All payments are to be paid to the **Bail Enforcement Agency/Investigators** within 72 hours of being emailed the invoice. Late Payments accrue 10% interest annum. All prior agreements are void. There are no modifications unless in writing and signed by all parties. Fees shall be earned upon cancellation by Bondsman/Client, Arrest of Defendant/Fugitive, Exoneration of Bail Bond, or any act described above in Methods of Exoneration.
